Your Health Care Reimbursement Account (HCRA) from BenefitWallet® and the Judiciary allows you to set aside pre-tax dollars to pay for eligible out-of-pocket expenses. When you spend your HCRA funds on qualified expenses, you are never taxed. You can use the funds in your HCRA to pay for a broad range of health care expenses for you, your spouse and your tax dependents, even if they aren't covered by your health plan.

What qualifies?



Doctors, Labs, and Hospitalization

- Doctor's office visits and procedures
- Hospital services
- Drug addiction treatment
- Laboratory fees
- Ambulance services
- Surgery, excluding cosmetic surgery
- Fertility treatment
- Vasectomy
- Health plan deductibles and copayments



Prescriptions and Medical Devices

- Prescription drugs
- Crutches
- Over-the-counter medications prescribed by a doctor
- Hearing aids and batteries
- Artificial limbs
- Insulin
- Bandages
- Stop-smoking programs and nicotine gum or patches
- Blood sugar test kits
- Walkers
- Breast pumps and lactation aids
- Wheelchairs

- Acupuncture
- Psychiatric care for mental health
- Alcoholism treatment
- Special education for learning disabilities
- Chiropractor
- Speech therapy
- Drug addiction treatment
